AN ORDINANCE ESTABLISHING A GRADE ON A PORTION

OF WASHINGTON STREET, IN THE BOROUGH

OF BENTLEYVILLE, WASHINGTON

COUNTY, PENNSYLVANIA.

BE IT ORDAINED AND ENACTED by the Town Council of the Borough of Bentleyville, Washington County, Pennsylvania, and it is hereby ordained and enacted by the authority of the same:

Section I. That the grade of the curb lines on Washington Street, from the East curb line of First Avenue to the Western curb line of Western Avenue shall be fixed and established as follows:

Beginning at the intersection of the East curb line of First Avenue and the North curb line of Washington Street: thence. Westwardly, level, across First Avenue, a distance of 24 feet, to the Western curb line of First Avenue, to an elevation of 964.5 feet; thence following the Northerly curb line of Washington Street. Westwardly, by an ascending grade of 11.33 %, for a distance of 136 feet, to the Eastern curb line of Second Avenue, to an elevation of 979 feet; thence level, across said Second Avenue, a distance of 24 feet to the Western curb line of said Second Avenue, to an elevation of 979 feet; thence Westwardly, following the Northerly curb line of Washington Street, by an ascending grade of 6.33 %, for a distance of 146 feet, to the Eastern curb line of Third Avenue, to an elevation of 988.24 feet; thence level across said Third Avenue, a distance of 24 feet to the Western curb line of said Third Avenue, to an elevation of 988.24 feet; thence, Wwstwardly, along the Northerly curb line of said Washington Street, by an ascending grade of 7.37%, for a distance of 146 feet to the Eastern curb line of Fourth Avenue, to an elevation of 999 feet; thence, acress said Fourth Avenue, level, to the Western curb line of said Fourth Avenue, a distance of 24 feet, to an elevation of 999 feet; thence by an ascending grade of 8.37%, Westwardly, along the Northerly curb line of Washington Street, a distance of 406 feet to the Eastern curb line of Western Avenue, to an elevation of 1033 feet; thence level across said Western Avenue, a distance of 24 feet, to the Western curb line of Western Avenue, to an elevation of 1033 feet; thence, returning by the Southerly curb line of Washington Street; beginning at the intersection of the continuation of the Western curb line of Western Avenue and the Southern curb line of Washington Street, , at an elevation of 1033 feet; thence in an Easterly direction, level for a distance of 24 feet, to an elevation of 1033 feet; thence Eastwardly, following the Southerly curb line of Washington Street, by a descending grade of 8.37%, for a distance of 406 feet to an elevation of 999 feet; thence Eastwardly, along the same, a distance of 24 feet, level, to an elevation of 999 feet; thence Eastwardly, along the same, by a descending grade of 7.37% for a distance of 146 feet, to an elevation of 988.24 feet; thence Eastwardly, level, a distance of 24 feet, to an elevation of 988.24 feet; thence East-Wardly, by a descending grade of 6.33%, along the same, a distance of 146 feet, to the Westerly curb line of said Second Avenue, at an elevation of 979 feet; thence level, across said Second Avenue, a distance of 24 feet, to an elevation of 979 feet; thence Eastwardly along the same, a distance of 136 feet, by a descending grade of 11.33 %, to a point opposite the continuation of the Westerly curb line of said First Avenue, to an elevation of 964.5 feet; thence 1 level, a distance of 24 feet, to a point opposite the continuation of the Easterly curb line of said First Avenue, to an elevation of 964.5 feet.

Section 2. All Ordinances or parts of Ordinances inconsistent herewith, be and the same are hereby repealed.
